- 5. (a) Names of (b) addresses of and (c) relationship to beneficiaries.
- 6. (a) Names of (b) addresses of and (c) relationship to executors, if not the beneficiaries, someone you can trust must be over 18.
- 7. Details of gifts note children will not be able to take gifts until they are 18 years old. You can provide for a later date for them to take the gift.
- 8. Gift over to children? i.e. if the beneficiary dies do you want their share to go to their children or the surviving beneficiaries?
- 9. Guardians for children you may wish to appoint one or more guardians in the event that both of you die when your children are under 18 years old. This will not be binding on a court but a court would take into account your wishes. Please let us have their name, address and relationship to you (if any).

- (a) Are you married?
- (b) Do you have children? If so, let us have their names and ages.
- (c) Do you have dependants? If so, let us have their names and ages.
- 11. Do you wish to express a desire in the will as to whether you wish to be cremated or buried?
- 12. Value of estate if over £325,000.
- 13. Details of any:
- (a) Jointly owned property.
- (b) Nominations for life policies or interests under a pension. You will have to make a nomination with the company as normally these do not belong to you to give by will.

#### NOTE:

- 1. With property abroad, you should consult a lawyer in that country to ensure any provisions are valid there.
- 2. We do not give tax advice. You should take advice on the tax consequences of this transaction from your accountant or tax advisor. You should do so particularly if your assets after payment of any mortgages or other debts exceed £325,000 and you have business assets. Shares in businesses are sometimes treated as business assets.

Please bring ID such as a driving licence or passport. A photo travel pass is acceptable if you don't have a passport or driving licence. This is so we can confirm that it was you that executed the will if there is a dispute.
